RE: PUBLICATION OF FALSE AND DEFAMATORY ALLEGATIONS CONCERNING THE GHANA FOOTBALL ASSOCIATION

We write on behalf of the Ghana Football Association (“GFA” or “our Client”) in respect of a video published on your Facebook page, Bigscout Media, and your YouTube channel, @bigscoutmedia6299, on 5 July 2026.

The said video featured a woman who purported to be the cousin of Mr. Prince Owusu, a professional footballer who plays for CF Montréal in Major League Soccer (MLS). In the said video, she made allegations concerning Mr. Owusu’s purported consideration for a call-up to the Black Stars ahead of the 2026 FIFA World Cup.

In particular, she alleged, in substance, that officials of the GFA demanded seventy per cent (70%) of Mr. Owusu’s earnings as a condition for facilitating his call-up to the Black Stars; that the demand was rejected by the player’s family and management; and that the parties subsequently agreed to a fifty-fifty (50-50) arrangement, upon which the GFA failed to revert because the arrangement was allegedly not favourable to it.

Although the allegations were made by the interviewee, you and Bigscout Media published, disseminated and gave a platform to the allegations through your Facebook page and YouTube channel without verification and without affording the GFA any opportunity to respond.

Our Client wishes to state that the foregoing allegations are entirely false, baseless and without any factual foundation. At no time did any official of the GFA demand, solicit, negotiate or agree to receive any percentage of Mr Owusu’s earnings, whether in connection with a prospective call-up to the Black Stars or otherwise.

The publication is misleading and defamatory of our Client. It falsely imputes corruption, improper conduct and abuse of office to the GFA and its officials, thereby exposing our Client to public ridicule, contempt and serious reputational harm.



In the circumstances, we hereby demand that you:

1. immediately remove and permanently delete the said video and all related publications from your Facebook page (Bigscout Media) and YouTube channel (@bigscoutmedia6299);
2. cease and desist from publishing, disseminating or republishing the allegations, or any allegations of a similar nature, concerning our Client or its officials;
3. publish a clear, prominent and unqualified apology and retraction on both your Facebook page and YouTube channel, with equivalent prominence to the original publication;
4. provide a written undertaking that you will not publish, disseminate, repeat or cause to be published any of the allegations complained of, or any substantially similar allegations, concerning our Client or its officials;
5. preserve all digital materials, recordings, metadata, messages, communications, and any related content connected to the publication, including any source materials and engagement data, pending further notice from our Client, in order to avoid spoliation of evidence; and
6. confirm in writing, within forty-eight (48) hours of receipt of this letter, that you have complied with the above demands.

Take further notice that failure to comply may occasion the initiation of proceedings for defamation and injunctive relief, and our Client expressly reserves all rights in that regard, including but not limited to any remedy in damages and such further ancillary reliefs as may be
